

Inkheart Drawing Competition Terms & Conditions

1. No employees or sub-contractors of HOME, their families or agents shall be eligible to win.
2. Entries for competitions will only be accepted from Thursday 8 October 2015 until Thursday 3 December inclusive.
3. A winner will be selected each week during the competition. Following the closing date, an overall winner will be chosen from the weekly winners. The judges' decision is final and no correspondence will be entered into.
4. Winners must be between the ages of 8 and 16 during the competition.
5. Weekly winners will each receive the prize of a free copy of *Inkheart* by Cornelia Funke.
6. The overall winner will receive family tickets to any performance of *Inkheart* at HOME, be invited to meet Cornelia Funke on Sunday 13 December and a family meal at HOME.
7. Family tickets are defined as up to five tickets with at least one adult (18 years old or over) and one child (16 years or under) and are subject to availability and must be booked at least two days in advance.
